



Terms & Conditions

1. The tournament will be conducted at St David's Marist Inanda.
2. Unless otherwise stated, the rules of FIBA (OBR 2024 effective 1 October 2024) shall be followed.
3. Only bonafide students of the school (in Grade 11 and lower) will be allowed to play in the tournament. Players will be verified by producing a birth certificate, student card, or ID card or book.
4. The prescribed entry form duly signed by the Head of Sports / MIC must reach the tournament organizers on or before the first match of the tournament.
5. The tournament will be conducted under a round robin basis. The top two teams in each pool will proceed to the Elite Eight (quarterfinals), the winners of the Elite Eight matches will proceed to the Final Four (semi-finals). The Top Two will compete in the Finals. Following the round robin games, the lower two teams in each pool will cross and play classification games until the final placements are determined. Teams in Pool A will cross to Pool D and those in Pool B will cross to Pool C.
6. All games shall be played as follows:
 - Playing time:** 4x8 minutes Stop-Start. 3 minutes Overtime period.
 - Shot clock:** 24 seconds shot clock will be used. Shot clock reset to 14 seconds after offensive rebounds.
 - Time outs:** 2 in the first half, 2 in the second half (only 2 in the last two minutes of 4th quarter) 1 time in Overtime. All timeouts will be 60 seconds long.
 - Team Benches:** The first team listed (left) on the schedule is the home team and bench is located to the left of scoring table and must shoot at the basket in front of their bench in the first half per FIBA Rules 2024 in effect from 1 October 2024.
 - Uniforms:** The first team listed (home team) shall wear light-coloured shirts (preferably white). The second team listed (away team) shall wear dark-coloured shirts. However, if the two (2) teams agree, they may interchange the colours of the shirts.
7. Coaches are responsible for the conduct of their team throughout the tournament.
8. The tournament committee reserves the right to alter the fixture and to refuse or accept entries of any team without assigning any reason thereof.
9. Protest if any shall be made through the captain or coach to the technical committee within 15 minutes, following the end of the game with a fee of R500 to be paid within an hour after the match, which shall be refunded only if the protest is upheld.
10. The players must show utmost sportsmanship, discipline, and decency inside, outside the court, and on the campus. The Coach / Manager shall be responsible for the proper behaviour of each member of his/her team.
11. In case of any loss or damage caused to any of the St David's Marist Inanda property, such loss or damage will have to be compensated by the responsible person/team.
12. Winners and runners-up team will be given trophies, medals, and individual prizes.
